In exercise of the powers conferred upon it by the Local Authority (Assignment of Functions - the Provisions of Parking Places and Stands and the Licensing of Private Parking Places) Order 1973 and all the enabling powers vested by the Local Government Ordinance 1961, the Tawau Municipal Council hereby makes the following by-laws:

**Citation and commencement.**

1. These by-laws may be cited as the Tawau Municipal Council (Parking Places) By-laws 1982 and shall come into force on the 1st day of January 1983.

**Interpretation.**

2. (1) In these By-laws, unless the context otherwise requires –

“Council” means the Tawau Municipal Council;

“hour” and “half hour” includes part of an hour or part of an half-hour as the case may be;

“hourly parking” and “half hourly parking” means in each case a parking place described in column 3 of the First Schedule hereto, wherein a motor vehicle is allowed to be parked on payment of the prescribed charge;

“length of road” means the entire length of the road as named in the Schedules;

“motor vehicle” does not include any motorcycle or motor scooter;

“parking” includes waiting in a parking space;

“parking attendant” means any person appointed under by-law 6 and includes a person authorised by or on behalf of the Council to supervise any of the parking places specified in the Schedules hereto and to collect parking charges;

“parking space” means the space marked out in a parking place for the parking of one motor vehicle;

“prescribed charge” means the charge prescribed in the Schedules hereto;

“road” means any public road and any other road to which the public has access and shall include back lanes, kerbs, sidewalks, sidetables, pavements, footway or passage, whether a thoroughfare or not and all channels, drains and ditches at the side of any road;

“Season parking (reserve)” means a parking place described in column 3 of the First Schedule hereto, wherein may be parked only motor-vehicle in respect of which a season parking ticket (reserve) has been purchased for a specified period. The fee is one hundred ringgit a month;

“Season parking (mobile)” means any person on payment of a prescribed fee for a prescribed period may park any motor vehicle in any parking space (except those reserved parking space) as described in column 1 of the First Schedule hereto. It is not a season parking (reserve) ticket. The fee is fifty ringgit a month;

“season parking ticket” means the official receipt issued by the Council showing the registration number of a motor vehicle and the amount of the prescribed charge for the parking of such vehicle in a specified season parking place for any period as may be stated therein;

“taxi” means a taxi cab or hire car which in the usual course of business plies for hire within or without the boundaries of the Council area.

**Provision for parking places.**

3. (1) The road, length of road or place specified in column 1 of the First Schedule shall be the parking places for motor vehicles other than taxis.

(2) The road, stretch of road or place specified in the Second Schedule shall be the parking places for taxis.

**Restriction on parking other than a parking place.**

4. (1) No person shall park any motor vehicle in any place on any road or length of road on which or adjacent to or in close proximity to which there is a parking place except in the case of a motor vehicle other than a taxi in a parking place specified in column 1 of the First Schedule and in the case of a taxi in a parking place specified in the Second Schedule.

(2) In relation to a parking place specified in the Second Schedule, the taxi using the parking place shall be subject to such conditions as the Council may deem fit to impose and any person using such parking place shall comply with such conditions.

**Parking spaces.**

5. (1) A parking place may be divided into parking spaces and for the purpose of determining the parking spaces the Council shall cause each parking spaces to be indicated by painted lines, stude, signs or other indications.

(2) There shall be erected at a parking place a sign or notice board on which shall be affixed a notice stating the substance of these By-laws and the prescribed charges.

(3) On the application of any firms, companies, institutions or other organisations including those mentioned below, the Council may, at its own discretion, reserve parking spaces for such firms, companies, institutions or other organisations at a charge as may be prescribed by the Council from time to time –

(a) Banks;

- (b) Hotels;
- (c) Tyre shops;
- (d) Dealers in motor vehicles with showrooms.

**Parking attendants.**

6. The Council may appoint one or more parking attendants to be on duty at a parking place.

**Method of parking.**

7. (1) No person shall park a motor vehicle in a parking space across any line marking the parking space or in such a position that the motor vehicle shall not be entirely within the area delineated as parking space.

(2) A person parking a motor vehicle in a parking space shall subject to the provisions of paragraph (1) of this by-law cause such vehicle so far as the lines marking the parking space permit to face the general direction of traffic and shall conform to all signs and signals exhibited in such parking place.

(3) Where any motor vehicle is parked in a parking space in contravention of the foregoing provisions a parking attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions, and the driver or person in charge of such vehicle shall comply with such lawful instructions as a parking attendant or a police officer in uniform may give in order to comply with the provisions of this by-law.

**Payment of prescribed charge.**

8. (1) Any person using a parking space shall obey all lawful directions given to him by a parking attendant and shall pay the prescribed charge as soon as the vehicle has been parked or on leaving the parking place by handing over the money to the parking attendant at the parking booth or *pondok* situated at a place as determined by the Council from time to time and the parking attendant shall issue an official receipt therefor on which shall be written the registration number of the motor vehicle, the amount paid, the date and

time which the motor vehicle is authorised to be parked at such parking place. The driver or person in charge of such vehicle shall thereupon affix a duplicate copy of the official receipt to the windscreen or any conspicuous part of the motor vehicle. The official receipt must be kept for at least six months from the date of its issue by the driver or person in charge of such vehicle and must be produced to the Council when demanded to do so during that period.

(2) Any person using a season parking place for the parking of any motor vehicle shall obey all lawful directions given to him by a parking attendant and as soon as the motor vehicle has been parked shall produce to the parking attendant on duty the season parking ticket in respect of the vehicle to be parked.

(3) Provided that any person using more than one parking space in a parking place or season parking place by reason of the size of his motor vehicle, he shall pay the prescribed charge for each space or part of such space so used by him.

**No parking without receipt.**

9. No person shall –

(1) park or cause or permit to be parked any motor vehicle in any parking place where there is a parking attendant unless he has the receipt of the parking attendant indicating that such payment has been made;

(2) continue to park or cause or permit or continue to be parked any motor vehicle in a parking space after the expiry of the period during which such motor vehicle is authorised to be parked in such parking space as stated in the official receipt issued by the parking attendant.

**Advice note.**

10. (1) Where a motor vehicle is parked in contravention of by-law 9 it shall be the duty of the parking attendant to issue an advice note to be affixed to the windscreen or any conspicuous part of the motor vehicle requesting the registered owner or any person in charge of such vehicle to pay the appropriate parking charge before the expiration of fourteen days from the date of the advice note failing which a surcharge will be imposed. Such advice note shall contain the following particulars –

- (a) the registration number of the vehicle;
- (b) the date of issue;
- (c) the time of issue;
- (d) the charge payable;
- (e) the parking space number.

(2) If the motor vehicle for which an advice note has been issued remains parked after the expiry of an hour or half an hour, as the case may be, from the time of the issue of the previous advice note the parking attendant shall issue another advice note and shall continue to do so at the end of every hour or half-hour as the case may be.

**Surcharge.**

11. If the registered owner or any person in charge of a motor vehicle, in respect of whom an advice note is issued in accordance with the provisions of by-law 10 fails to pay the charge or charges within the time prescribed in the advice note first issued, he shall pay a surcharge of two ringgit for every hour or half-hour, as the case may be, during which the motor vehicle has been parked in contravention of by-law 9 subject to maximum of twenty ringgit on any one occasion.

**Restriction against parking second time on original receipt.**

12. (1) No person having removed his motor vehicle from a parking space before the expiry of the authorised period for the parking of such motor vehicle shall be entitled to park such vehicle in the same parking space a second time without further payment of the prescribed charge notwithstanding that the original authorised period has not yet expired.

(2) The provision of paragraph (1) of this by-law shall not apply to the holder of a valid season parking ticket (reserved), parking a motor vehicle in a reserved season parking space.



**Safety of other vehicles.**

13. No vehicle shall be drawn, driven or pushed within a parking place otherwise than in an orderly and careful manner and with due regard to the safety of other vehicle and persons within the parking place.

**Suspension and limitation of use of parking places, spaces.**

14. (1) The Council may suspend or limit the use of a parking place or space whenever it considers necessary.

(2) On any such suspension or limitation, the Council shall cause to be affixed an appropriate notice in relation to the parking place or space, and it shall be unlawful for any person to park any motor vehicle in such parking place or space except for the purpose for which the suspension or limitation is made.

**Vehicles exempted.**

15. These By-laws shall not apply to –

- (a) any ambulance or any fire engine or any vehicle in the service of the Army, Police or the Post Office;
- (b) any vehicle in the service of any authority authorised by or under any written law, or under any order having the force of any written law, to construct, erect, or carry on electricity, water or other public undertaking, in so far as such vehicle is being used in the construction, erection or carrying on of the undertaking; and
- (c) a vehicle which has been directed to a parking space by a police officer in uniform in the course of his duty.

**Obstruction and removal thereof.**

16. (1) No person shall obstruct or cause to be obstructed any parking space.

(2) A parking attendant or any person authorised in that behalf by the Council may remove any object which is the cause of such obstruction, and the owner or owners of such object may within twenty-one days of such removal reclaim from the Council possession of such object upon payment to the Council of the cost of removal and custody of the object.

(3) The Council may at any time, if the object is of a perishable nature, and after twenty-one days in any other case, dispose of the object in such manner as it thinks fit and shall refund the proceeds thereof to the owner less the cost mentioned in paragraph (2) of this by-law and any other cost incurred in connection with the disposal, and in the event of there being, no claim, the proceeds may after twelve months of the disposal be credited to the revenue of the Council.

(4) The Council shall not be liable for any loss or damage to the object in the course of its removal and whilst in the custody of the Council.

**Removal and detention by Council.**

17. (1) If for any reason a motor vehicle other than a motor vehicle parked in the parking space for which a season parking ticket has been issued has been left in a parking place for more than two days the Council may cause the vehicle to be removed from the parking place to a place of safety and detained there until released by order of the Council.

(2) The Council may detain such motor vehicle until the prescribed charge for the unpaid period up to the time the vehicle is removed from the parking place and all reasonable expenses incurred in carrying out the provision of this by-law have been repaid to the Council.

(3) The Council shall not be liable for any damage to the motor vehicle or for any loss or damage to the fittings or contents of the motor vehicle so removed and detained by the Council under the provisions of this by-law.

**Notification of removal and detention.**

18. When an object or a motor vehicle is removed or detained in pursuance of the provisions of by-law 16 or 17 the Council shall with all reasonable despatch give notice in

writing to the owner thereof, if the name and address of such owner be known, of the removal or detention of such object or motor vehicle.

**Motor vehicle may be rendered immobile.**

19. (1) When any motor vehicle is parked in contravention of any of the provisions of these By-laws the parking attendant or any person authorised in that behalf by the Council may render such motor vehicle chained and locked by the use of any device as the Council may think fit, and no person shall remove such motor vehicle or tamper with the chain and lock. On the request of and subject to the owner or person in charge of such motor vehicle paying to the Council such fees not exceeding fifty ringgit as may be determined by the Council, the Council may remove the chain and lock and release the motor vehicle.

(2) The Council shall not be liable for any damage caused to the motor vehicle in the course of and whilst it is being chained and locked.

**Prohibition of trade or business.**

20. No person shall use any motor vehicle parked in a parking space for the purpose of carrying on any trade or business except in the case of goods vehicle for the delivery of goods and on payment of the prescribed fees.

**Prohibition of repairs.**

21. No person shall repair a motor vehicle or permit a motor vehicle to be repaired in a parking place except in cases where the repair is necessary to enable the motor vehicle to be removed from the parking place.

**Prohibition of washing or cleaning.**

22. No person shall wash or clean or cause or permit to be washed or clean any vehicle in a parking place.

**Persons permitted in parking place.**

23. No person other than a parking attendant, driver, person in charge or passenger of a motor vehicle parked in a parking place shall be or remain in such parking place.

**Removal of receipt of advice note prohibited.**

24. No person other than a person authorised by the Council shall remove or cause to be removed any receipt of advice note issued by a parking attendant and affixed to the windscreen or any conspicuous part of a motor vehicle whilst being parked in any parking place or space.

**Provision of signboards.**

25. The Council shall provide a signboard or signboards at each parking place indicating whether it is a season or hourly or half hourly parking place and may erect such signs and signals as may be considered necessary for the direction or regulation of motor vehicles within the parking place.

**Emergency.**

26. In the case of emergency, any person authorised in that behalf by the Council, or any police officer in uniform, may move or cause to be moved to any place he thinks fit any motor vehicle left in any parking place.

**Registered owner's liability.**

27. When the Council has reasonable grounds for believing that an offence has been committed under these By-laws, and the name of the driver or person in charge of the motor vehicle is unknown, the Council may by notice require the registered owner of the vehicle to disclose to it the name and address of the driver or person in charge of the motor vehicle at the time of the commission of the offence, and the registered owner shall comply with such request within twenty four hours of receipt of the notice.

**Council not liable for loss or damage.**

28. The Council shall not be liable for any loss or damage to any motor vehicle or the fittings or contents of any motor vehicle parked in any parking place.

**Penalties.**

29. Any person who contravenes any of the provisions of these By-laws, shall be guilty of an offence and shall on conviction be liable to a fine not exceeding one hundred ringgit and in addition there shall be paid to the Council any surcharge due and payable under the provisions of these By-laws.

**Compounding of offences.**

30. The Council may compound any offence under these By-laws by collecting from a person reasonably suspected of having committed such an offence a sum not exceeding fifty ringgit and on payment of such sum of money no further proceedings shall be taken against such person in respect of the offence.
